Tax Base For Resident and Foreign Companies.Â Foreign companies are generally subject to the same corporate tax as domestic companies. However, taxable income is calculated on Effectively Connected Income (ECI) only, which is considered as all U.S.-source income derived from trade or business in the U.S. or sale of U.S. real property or inventory by a foreign entity. ECI tax exemption can also be applied through a tax treaty. US taxation of income earned by non-US entities depends on whether the income has a nexus with the United States.
